*Please remember to contact the city office if you are starting/stopping utility service, replacement or extra garbage container, or if there is a street light out. You can also pick up an automatic payment form for your utility bill. Also, update phone numbers is appreciated in case of emergencies. Thanks!*

### **1-11-10. Tree Removal and Trimming on Private Property**

1. Every owner of any tree overhanging any street or right-of-way within the City shall prune the branches so that such branches shall not obstruct the light from any street lamp or obstruct the view of any street intersection and so that there shall be a clear space of 14 feet above the surface of the street or right-of-way. Said owners shall remove all dead, diseased or dangerous trees, or broken or decayed limbs which constitute a menace to the safety of the public. The City shall have the right to prune any tree or shrub on private property when it interferes with the proper spread of light along the street from a street light, could potentially damage public improvement equipment, or interferes with the visibility of any traffic control device or sign, such pruning to be confined to the area immediately above the right-of-way.

2. The City shall have the right to cause the removal of any dead or diseased trees on private property within the City, when such trees constitute a hazard to life and property, or harbor insects or diseases which constitute a potential threat to other trees within the City, and such trees are hereby declared to be a nuisance and unlawful.

## Pet Licenses



Don't forget that ANY pets 6 months or older need to be licensed annually (Renewal Jan 1<sup>st</sup> every year) Spayed/neutered is \$5.00, and non-spayed/unneutered is \$10.00. Please also bring in a copy of your pet's updated rabies vaccinations.

### **Animal Ordinance Summaries**

#### **6-01-02. At Large and Wastes.**

Dogs and Cats must be leashed upon the streets, public places, public ways, school grounds or private premises of any person other than the owner. Animal owners must properly collect and dispose of their dog's or cat's solid waste.

#### **6-01-04. Noisy Animals.**

Owners must control loud and frequent yelping, barking, or howling which annoys any person.

#### **6-03-03. Impound Fees.**

1st offense per animal \$25  
2nd offense of same animal within 12 months \$50  
3rd+ offense of same animal within 12 months \$75  
Plus \$10 each day for feeding and care

#### **6-03-04. Redemption of Unvaccinated, Unlicensed Dog or Cat.**

A deposit of \$15.00 will be held for 24 hours to get each dog or cat vaccinated and properly licensed. If owner fails to provide rabies and city license within 24 hours, the dog or cat shall again be seized and impounded.
